# Friendship ABY Camp, Inc. Rules and Instructions

#### **2024 Camp Dates and Locations:**

Primary: Grade 3-5 Junior: Grade 6-8 Senior: Grade 9-12

#### **Camp Rules:**

- **Dress Code:** Modest summer attire is appropriate. Modest length shorts, regular T-shirts without offensive or inappropriate messaging, one-piece swimsuit *required*. The key biblical word for all ages for camp dress code is Modesty! The camp leadership will have discretion on dress at camp and will have the authority to require campers to change if dress is inappropriate. Indiana State law requires shoes to be worn, at-all times, except at the swimming pool. Camp leadership prefers tennis shoes rather than flip flops for most activities.
- **Electronic Devices:** Campers are not permitted to have any type of electronic devices including cell phones while at camp. The Camp Dean will collect electronic devices, if found, and safely store until the end of camp.
- Conduct: Camp staff expects all campers to respect the authority of Camp leadership.
  - 1. Grooming: Campers are expected to maintain good personal daily hygiene.
  - 2. Language: Foul/abusive language is not permitted, including euphemisms/suggestive language.
  - 3. Body Art: Piercing pieces must not be worn at camp and inappropriate tattoo images must be covered while at camp.
  - 4. Substance Use: Tobacco use, vaping, alcohol, illegal drugs and, etc. are strictly prohibited at camp.
  - 5. Inappropriate Touch: Campers must not participate in public displays of affection or inappropriate and excessive touch while at camp.
  - 6. Rule-of-Three: Campers should never be alone one-on-one with anyone, anywhere at any-time.
  - 7. No-Go-Zones: Camp Rules posted on cabin doors will clearly identify No-Go-Zones in camp vicinity.
  - 8. Physical/Verbal Abuse: Any form of physical or verbal abuse is strictly prohibited.
  - 9. Weapons: No kind of weapon is permitted at camp.
  - 10. Food: The camp provides all food and snacks at camp. Do not bring food or snacks to camp.

### **Camp Instructions:** What to bring to camp.

- Bedding: Bring your own pillows, sheets, blankets, etc. (Bunks w/. twin size mattress provided at camp.)
- Toiletry and Bathing items: Bring your own personal hygiene items. (Showers at camp available daily)
- Appropriate Clothing: Bring a weeks' supply of clean clothing. (See Camp Dress Code)
- Flashlight with fully charged batteries: ("So let your light shine among men".)
- Sunscreen: (We recommend waterproof SPF 30min.)
- Insect Repellant: (Check for safe use on children)
- One-Piece Swimsuit: (See Dress Code)
- Towels: Bring enough towels for daily showers and swimming.
- Small Fan: Cabins are not air conditioned. Small fans are permitted but AC units are not.
- Prescription Drugs: A week supply of personal prescription drugs. (Turn in to Camp Medical Staff)
